- Day-to-day screening of operation on-site about a safe system of work as proactive Monitoring.
- To implement the company's documentation like HSE plan, Road safety plan, Waste management plan, Emergency plan, etc. as per training to the client requirements.
- Prepare Daily/Weekly/ safety report returns for submission to the client.

- Inspect the construction site and advise on various HSE issues the Construction team.
- Inspect equipment, machinery, and tools to ensure safe and proper use to avoid and bypassing of safety devices.
- Maintained Material Safety Data Sheet (MSDS) on chemicals used in the workplace.
- Identified, recommended, and implemented ergonomic changes to reduce health and safety hazards.
- Ensuring the quality of the Personal Protective Equipment and workmen's acceptance to use them.
- Maintain fire-fighting appliances and life-saving equipment
- Performed daily walkthroughs for safety inspections of the facilities including fire systems. Documented and photographed findings and complied and presented statistical data on safety activities to the EH&S director. Coordination of fire extinguishers where necessary.
